



#### Bible Study: The Most Important Miracle



Sometimes we may wonder what good God's forgiveness does. It doesn't always seem like this Gospel proclamation—"Your sins are forgiven!"—makes much of a difference.

It doesn't do our dishes, cook our dinner, work our job, or fix our car. It doesn't raise our children, impress our friends, or silence our critics. It doesn't solve our conflicts, cure our illnesses, increase our intelligence, or improve our appearance. Meanwhile, we watch as someone else gets a financial blessing. We witness someone else get an answer to prayer. And someone else gets an angel visit, a conversion experience, or spiritual fire. And someone else saw a vision, heard a voice, or spoke in tongues. But all we got was this lousy forgiveness.

How can that help when folks can't afford another baby? How can that answer when the doctor says, "I'm sorry"?

Read Matthew 9:1-8. What comfort comes from the simple detail that this takes place in "His own city"? Consult Psalm 95:4-5, John 1:10-14, and Philippians 2:5-8 for clues.

What hardships do you imagine this fellow suffered as a paralytic? What difficulties does surprise pregnancy bring? How might someone suffer after an abortion? And during a terminal illness?

Look up John 9:1-3 and Romans 3:22b-24. Why doesn't the Gospel highlight how he became paralyzed?

What do Genesis 3:16-19 and 1 Corinthians 7:31b explain as the ultimate answer to why anyone suffers?

Compare with Mark 2:3 and Luke 5:19. How did the Lord care for him in his affliction?

Whom does God provide to accompany individuals amid surprise pregnancy? Terminal diagnosis?

What does Jesus notice first about the situation in Matthew 9:2? What does this reveal about what gives human life its real value? Check 1 Samuel 16:7, Matthew 18:8-9, and John 15:5 to illuminate.

See Luke 5:21 and James 2:15-16. Why does Jesus' statement astonish the audience? What incredible claims do Gospel-motivated voices make about unborn and impaired persons?

How do these words of Jesus provide precisely the solution to the fellow's situation? Find hints in Matthew 6:33, Romans 8:32, and Revelation 21:5.

Now check with Psalm 103:2-3, 1 Peter 2:24, and 1 Corinthians 1:18. What does forgiveness have to do with healing? How is authority over sin related to power over disease and death?

Turn to 2 Corinthians 4:7, 2 Corinthians 12:9, and Psalm 34:18. What meaning did Jesus give to the man's healing? How did this also give meaning to his hurting?

How can we embody these blessings for our neighbors dealing with life-and-death circumstances?

#### One Mind/One Voice

I was installed into my new position as the director of The Lutheran Church – Missouri Synod (LCMS) Life Ministry in the summer of 2020. In the months since, many of the conversations that I have with members of LCMS congregations begin with the phrase, "What is the official LCMS position on ..." and an interesting discussion on the topic at hand ensues that often involves my explanation of how the LCMS comes to have official positions. The establishment of official position statements of the LCMS follows a pattern that began in the early Church.

Since the days of the apostles, the Church has gathered in councils (Acts 15) to seek to be of one mind and to speak with one voice in applying God's Word to issues that arise. Today in The Lutheran Church – Missouri Synod we follow in those footsteps by holding conventions where God's people gather to make decisions, walking together as local congregations organized into synodical districts. Some of the decisions that are made during modern district and synodical conventions, which occur every three years, establish the official positions of the LCMS on sanctity of human life matters. It is a very different process from that of non-profit organizations, such as Lutherans For Life, who generate position statements within a board of directors.



In addition to establishing the official position of the Church on particular contemporary issues, a convention also provides direction that guides the work of the Church, including that of synodical program ministry areas such as LCMS Life Ministry. Overtures submitted by congregations are a crucial part of the process that provide guidance to the work. If something is important to your congregation and you feel it is of value to the entire Church, write an overture and submit it through your district's convention process. (Please note districts have different deadlines and submission requirements.) Circuit forums are a place where neighboring congregations can work together on submissions to a district or Synod convention. Your brothers and sisters in Christ who make up the convention floor committees will study God's Word, consult with experts, pray about the submitted overtures, and through an organized discussion prepare the overtures to be presented to the convention for study, discussion, and vote by the delegates.

There is a proper written form for overtures that contain "Whereas" statements and then "Resolved" statements. You can see the instructions and templates for LCMS national overtures at www.LCMS. org/2022-convention-overture-instructions and www.LCMS.org/2022-convention-overture-template. For more information on upcoming 2021 district conventions, contact your LCMS district office. You can find their information on www.LCMS.org/districts. Good resolutions speak clearly and concisely



to the whole Church—and in some cases, beyond—and contain a clear and logically developed rationale that merits support for its proposed action. The process does take time and effort, but it is intended to produce quality resolutions with the purpose being that the Church would come to one mind and speak with one voice.



The Lutheran Church-Missouri Synod in convention has established official positions on abortion and stem cell research and has spoken out against the legalization of assisted suicide and legislation that does not value human life, along with many other issues. The LCMS in convention recently directed the Office of National Mission and LCMS Life Ministry to call a director, to sponsor conferences, and to create resources on beginning of life issues for college students and youth. Being specific in written overtures provides the path that district and synodical leadership will walk in upcoming years. This article is meant to be an explanatory summary, not a technical document; if you would like to know more about the process or resolutions on Life Ministry that the LCMS has passed in previous synodical conventions, please feel free to reach out to us at LifeMinistry@lcms.org.



## Lutherans For Life 2021 Non-Federation States Essay Contest

**Sponsored by the Council of Federation Presidents** 

#### For students in Grades 6 through 12

Any Lutheran student in a Lutheran school or church is eligible. Lutheran students may also enter through a home school or congregation (e.g. confirmation class, youth group) when validated by a pastor or teacher.

#### **Contest Guidelines**

Students will write a life-affirming essay based on the theme: **God Chose You** with the Bible verse: "You did not choose me, but I chose you and appointed you that you should go and bear fruit". (John 15:16)

- 1. Not incorporating the theme and verse in the essay will disqualify the entry.
- 2. Examples of topics the essay could deal with are, but not limited to: abortion, the handicapped, adoption or foster care, infanticide, cloning, stem cell research, physician-assisted suicide, or euthanasia, etc.
- 3. Essays should include student's name, grade (identify school or church), and email address. All entries submitted by a teacher or pastor should include their name and email address. This information should be submitted on the rubric page used in grading the essay.
- 4. All sources for references, statistics, and quotes should be incorporated within the essay and then included in a bibliography at the end.

Grades 6 - 8 should submit essays up to 400 words Grades 9 - 12 should submit essays up to 750 words

Entries should be submitted digitally using Microsoft Word or Google Docs to <a href="mailto:jduncan@lutheransforlife.org">jduncan@lutheransforlife.org</a> by April 1, 2021.

- 5. There will be a \$100 first place-award and \$50 second-place award for each of the two. The two first-place category winners will advance to the national contest. Email <a href="mailto:jduncan@lutheransforlife.org">jduncan@lutheransforlife.org</a> with any questions.
- 6. Grand Prize for the national winning entry at each level: \$250 plus free conference registration to a 2021 Regional Conference and one night stay at the conference hotel.
- 7. All entries become the property of Lutherans For Life.



#### Owen's Mission



Owen's Mission is a very special project of Lutherans For Life. The goal of this project is to honor Jesus

by presenting a set of *Touch of Life* fetal models to every Lutheran elementary and high school in the country. We want students to understand the God-given value of each life from the moment of conception. We want students to be motivated by what God has done as our Creator, Redeemer, and Sanctifier that gives value to life. We want students to value themselves and to value others as persons because of this God-given value.



"I held my little grandson Owen in the palm of my hand. He died at 21 weeks during prenatal surgery to remove a large tumor. The nurse brought him to our son as we waited in the recovery room for Owen's mother. I find it difficult to describe what I felt when I was able to hold him. I had held the 20-week *Touch of Life* fetal model in my hands hundreds of times in front of students from preschoolers to seminarians. Holding Owen revived in me the reality behind those models. I will never hold them in the same way again."





As Owen's grandpa, Dr. Lamb wanted to do something special to remember Owen, honor Jesus, and help others understand the value God gives to even the smallest of lives. With the help of Owen's family, *Owen's Mission* was born. We are training facilitators to present these fetal model sets along with a DVD message from Dr. Lamb.

#### Need a Speaker?

- Honorarium: Affiliated speakers for Lutherans For Life are not in a paid position. Therefore, we ask that sponsoring groups provide an honorarium for affiliated speakers. The sponsoring group determines the amount of the honorarium. Honorariums depend on number of events. Honorariums begin at \$200.
- Meals: \$25 per day unless other arrangements are made.



#### The Basics of Lutherans For Life

#### Structure and Relationships

A local Life Chapter is a local organization that has been chartered by National Lutherans For Life. The Life Chapter is formally associated with and subject to, but not a part of, the corporation known as Lutherans For Life, Inc.

A State Federation is an organization that has been chartered by Lutherans For Life, Inc., in a state where there are at least five chartered Life Chapters. In a state where a State Federation exists, the Life Chapters also become affiliated with the State Federation. This occurs automatically at the same time a Life Chapter becomes chartered by Lutherans For Life, Inc. These relationships are basically the same whether or not the Life Chapter is incorporated. Thus, Lutherans For Life consists of a network of individual entities formally associated with each other.

#### Membership Information

All officers of State Federations and Life Chapters and Life Ministry Coordinators must be members in good standing of Lutheran congregations and members of National Lutherans For Life.

Membership contributions are divided among the national organization, State Federation, and local Life Chapter if it is chartered.

Life Chapters that wish to include a membership form in newsletters or correspondence are asked to maintain the form and information provided by the national office.

The local Life Chapter may not establish its own membership program since LFL has a "unified membership" program. When sending a membership form to the national office, make sure the Life Chapter name and number, if chartered, is written on the form in the space provided. This will ensure that the State Federation and local Life Chapter receive the proper remittance payment.

#### **Membership Classifications**

#### Annual Membership

• Annual members join by making a membership donation accompanied by a completed copy of the membership form (or by joining online).

#### Sponsor Membership

- Sponsor members pledge to contribute a certain amount each month and to pray regularly for Lutherans For Life.
- Sponsor members receive a monthly letter from the executive director.
- Sponsor members are asked to renew their monthly pledge each year as part of the annual membership drive.

#### The Remittance Program of LFL

All MEMBERSHIP donations are shared with the chartered State Federation and/or local Life Chapter to which the particular members may belong. The membership donations are divided as follows:

#### Annual Memberships:

- 20% goes to the local Life Chapter (If there is no local Life Chapter, this 20% goes to the State Federation.)
- 20% goes to the State Federation
- 60% remains at national

#### Sponsor Memberships:

- 1/12 goes to the local Life Chapter (If there is no local Life Chapter, this 1/12 goes to the State Federation.)
- 1/12 goes to the State Federation
- 10/12 remains at national
